The City of Lincoln encourages recycling of many types of materials. Plastics 1-5, tin/aluminum cans, cardboard, newspapers, and mixed residential paper.

Our nearest recycling sites are:

- 1. North Star High School
- 2. South side of N. 48th St Landfill
- 3. Highlands Fire Station

The City Health Department also operates a hazardous waste recycling center adjacent to the 48th st landfill, where they take appointments on the 1st Wednesday or 3rd Saturday of each month by visiting haztogo.com or by calling (402)441-8021.
